### **President's Words**

Dear Members,

Greetings from the MSBOA are offered to one and all. Another Spring is upon us.

The weather, stallion selection, monitoring the expectant mares, early conditioning of our two and three-year -olds are all before us. Hope is what keeps all of us going as we plan for this year, 2026, 2027 and 2028.

Today an update about the legislative process is necessary. The fiscal issues facing the State are significant. Some of the legislators have mentioned re-examining the cascade funds that are distributed to the accounts of the Breeders, the MHHA, the Fairs, the OTBs, and the commercial tracks. Our lobbyist cautions that if the cascade is opened up, there is no knowing where or how it will all end.

In April or May, we will be afforded an opportunity to present our opinions at a public hearing at the State House in Augusta. Everyone is encouraged to speak and/or write to the members of the Legal and Veterans Affairs Committee (LVA) that has jurisdiction over the cascade.

When the public hearing date is established, we will send out notice. However, it will be short notice. Please take time and collect your thoughts about what breeding means to you. The trials and tribulations of producing a live foal makes for dramatic storytelling. Preparation of the yearlings for the introduction to their athletic careers will interest the 13 members of the LVA. The incremental reduction in training times for our two-year-olds is a mixture of advances and setbacks as we strive for making qualifying time. The two and three year-old circuit of Bangor, Cumberland, Topsham, Skowhegan, Windsor, Farmington, and Fryeburg present many opportunities for colorful memories.

We are trying to compile a list of people who will appear and speak to the LVA Committee about their love of breeding and racing horses in the State of Maine. We are looking for people to sign up, to attend and speak. If you would be willing to attend and speak please contact Rhoda Underhill at





#### **Survey Results**

#### Chapter 9 proposed changes

Our membership requested that the MSBOA Board of Directors create and send out a survey to the entire membership regarding the proposed changes to Chapter 9. These are the results from that survey. Along with what the MHRC decided regarding each of the questions asked.

#1

All fees (stallion, nomination, continuation, sustaining and entry) will increase: this was submitted by both the Fairness Committee and the 2024 Board of Directors because increases are long overdue. All fees will continue to be added to purses as they are now. Do you agree with the increase in fees?

RESULTS: 53 YES 11 NO

#2

Late Fees: Submitted by both the Fairness Committee and the 2024 Board of Directors to more clearly define late fees and to ensure consistency. Do you agree with the change in late fees?

RESULTS: **61** YES **3** NO

\*\*According to AAG Sawyer these changes are too significant and would require Legislative measures. NO changes in fees will occur at this time.\*\*

#3

Qualifying times adjusted by track size: submitted by Commission Staff to insure equality of timed performance. Do you agree with addition of qualifying times by track size?

RESULTS: 50 YES 14 NO

\*\*Qualifying times will be adjusted according to track size and allowances will be made for track conditions.\*\*


3-year-olds use of Lasix: submitted by Commission as a new condition for eligibility, horse must be "Examined" post-race by Commission Veterinarian and deemed in need of Lasix. Do you agree with this addition of Lasix for 3-year-olds?

RESULTS: 44 YES 20 NO

\*\*3-year-olds WILL be allowed the use of Lasix in the Maine Sire Stakes Program. The specific rules for placing a horse on Lasix will be available as soon as the rule is adopted.\*\*

The updated Chapter 9 will be available on our website as soon as it has been adopted. The Lasix rule and protocol will also be available on the website and shared on our Facebook page and emailed to all current members. It will also be posted at the tracks.

#### 2. Furosemide Program

- A. Stakes horses eligible to participate in the Furosemide Program:
  - Two year olds are not allowed on the Furosemide Program.
  - (2) Three year old horses eligible to participate in the Maine Sire Stakes Program are allowed on the Furosemide Program under these conditions:
    - a. The horse must race in the State of Maine and be endoscopically examined by a Commission Veterinarian following the race to verify exercise induced pulomanry hemorrhage (EIPH) in order to be eligible for the furosemide program in its three year old stakes season.
    - b. If a horse is placed into the furosemide program it will not be allowed to participate for eight (8) days after its last start beginning with the day after the race. This rule does not pertain to entering a horse.
